Such power may also include, without limitation, the authority to trade securities or other investment instruments, including the purchase and/or sale of option contracts for and at the risk of the Trust. We understand that all orders and transactions will be governed by the terms and conditions of all other account agreements applicable to this account. We have reviewed the entirety of the Trust document prior to completion of all application forms, and we have verified the accuracy of all information we have provided in this certification and in the completion of all application forms.

E. We, the Trustees, jointly and severally, in our capacities as trustees and individually, indemnify you and Computer Clearing Services ("CCS") and hold you and CCS harmless from any liability, claim, loss, expense, including attorney's fees for effecting any transactions, and acting upon any instructions given to you by any Trustees. We, the Trustees, certify that any and all transactions requested and all instructions given to you or to CCS regarding this account will be in full compliance with all provisions of the Trust.

F. We, the Trustees, agree to inform you, in writing, of any change in the composition of the Trustees, or of any other event, which might alter the certifications set forth within this document.

G. We, the Trustees, agree that any information we give to you regarding this account will be subject to verification, and we authorize you and/or CCS to obtain a credit report about any or all Trustees individually at any time. Upon written request, you will provide the name and address of the credit reporting agency used.

H. We, the Trustees, understand that CCS does not undertake to review individual transactions or instructions, and that CCS relies upon your instruction and the Certification and representation made to you hereunder. We, the Trustees, understand that it is our sole responsibility to limit the instructions given to you, and to request only those transactions, that comply with all provisions of the Trust.
